## **Executive Summary**

The University of New Brunswick, with campuses in Fredericton and Saint John, is the largest university in New Brunswick and plays a vital role in the creation and dissemination of knowledge to stakeholders in government, industry, the non-profit sector and the population at large. As one of the first Research Data Centres opened in Canada, the UNB-RDC is central to the creation and dissemination of social policy research by members of the Canadian Research Institute for Social Policy (CRISP), the faculty of Nursing, the Department of Economics, the Department of Sociology, the Atlantic Research Training Centre, and other departments and groups across the university.

The presence of the RDC and the opportunities available to researchers and policymakers continue to be instrumental in an ongoing initiative to develop connections among UNB faculty, graduate students, provincial government employees and NGOs that will benefit both the University and the wider community. The impetus came from a clear mission statement from the NB Department of Health and other Departments to move towards evidence-based policy evaluation and formation. At the same time, there was a clear recognition that the ability for the Province to undertake its own research program to assemble policy-relevant evidence was limited. In 2013 significant progress was made on the establishment of the New Brunswick Institute for Research, Data and Training, a close partnership between UNB and the Province of New Brunswick. When established in 2014, the NB-IRDT will offer a 'one-stop shop' of policy relevant research support including access to the Statistics Canada data through the NB-RDC and access to provincial administrative data through the NB-IRDT's own secure data platform.

Significant progress was also made in 2013 in establishing RDC branches in Moncton and at Memorial University in Newfoundland. The Memorial branch opened in early 2014 and the Moncton branch will open in the spring of 2014. The NB-RDC with a centre at UNB and branches at Moncton and Memorial will enhance research collaborations among those universities.

Research output declined in 2013 from 2012 in many categories. However, a significant increase in RDC activity in 2013 from both researchers and students should mean that output activity in 2014 will be higher. Dissemination of knowledge through conferences and workshops continues to be a strong point for UNB researchers. There is no output from Moncton or Memorial branches in 2013 but this will change in 2014.

### **Box 5a: Substantive Comments on Knowledge Mobilization Activities within the RDC**

In 2013, Dr. McDonald continued to conduct regular information sessions for individuals from the Government of New Brunswick as well as for the NB Social Policy Research Network, the NB-RDC's main partner. Dr. Haan had extensive media coverage of his work on demographic changes and outmigration, including interviews include AM talk radio, television (Global, CTV, CBC), newspaper (including the Globe and Mail, Fredericton Daily Gleaner, the Telegraph Journal, the Toronto Star), and CBC morning radio.

### **Vignette 1**

Dr. Haan studies intra- and inter-provincial migration, and the implications that these phenomena have for urbanization, labour market development, immigration, and population aging, and several other topics. Given the many intersections of his research, he maintains regular contact with multiple provincial and federal government departments, working on issues of mutual interest. One example of this research was a 2013 study that projected future enrolments in New Brunswick universities and colleges from 2011-2021. He used RDC census data and enrolment data held by the province, producing numbers that are the baseline values now being used by both New Brunswick post-secondary education institutions and the Government of New Brunswick for their policy planning. He has presented these results to presidents of all the colleges and universities in the province at the Annual President's Meeting, held in Fredericton in March 2013, and at the Annual General Meeting of the Council of Atlantic Ministers of Education and Training in Charlottetown in April 2013.

He also works to mobilize knowledge beyond the public sector. In the past four years, he has also given over 100 radio and television interviews, roughly fifty pro-bono public lectures, and written several commentaries in regional and national newspapers.

**Criterion 7: Summary of Major Achievements and Challenges for the past year**

One major achievement for the NB-RDC is that our total activity measured in terms of dyads surpassed 100 for the first time. We are now no longer the smallest RDC centre measured by total activity in RDCs.

There were two major, and related, challenges to the operation of the NB-RDC in 2013. The first was the delay in bringing Moncton and Memorial branches online. Moncton is still not yet open, with major delays arising from the second challenge, the migration of the RDC to the new network. This was complicated by the fact that since Moncton is connecting to our servers by way of a local thin client structure, and there were numerous delays in obtaining final approval for the Moncton-UNB joint network architecture document. This was finally worked out to the satisfaction of Statistics Canada in May 2014.

**Criterion 8: Major Objectives and foreseeable Challenges for next year**

Funding from the Office of the Vice-President Research will continue to be under great strain, forcing the NB-RDC to find other funding sources in order to sustain full-time operations. Data disclosure requests from Memorial seem to be proceeding well, but it remains to be seen how the thin client network between UNB and Moncton will perform. Both branches need actively to engage their research communities in order to generate research activity in their respective branches.
